Mr. Stewart discussed the findings of the SCSC visit to LT. We need to fix some policy issues within 30 days to get points back on the SCSC Performance Framework. Mr. Stewart is working on that. The SCSC commented favorably about LT during their visit.

Summer Camp information was presented. Concern was expressed that the number of students g interested in attending Summer Camp was lower than last year.

# **CSP Grant Update:**

Chrome books are being ordered for every student with CSP Grant money in increments as invoices are paid.

\$10,000 worth of Chrome books were recently ordered.
